Sir/Madam,

With reference to your application dated **29/06/2011** and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for **Senior School Certificate Examination** for a period of **three years w.e.f. 01.04.2012 to 31.03.2015** in the following subjects:-

- (a) Languages: - ENGLISH (CORE/ELECTIVE), FUNCTIONAL ENGLISH , HINDI (CORE/ELECTIVE)  
(b) Elective Subjects: - ECONOMICS, MATHEMATICS, PHYSICS, CHEMISTRY, BIOLOGY, COMPUTER SCIENCE, INFFORMATICS PRACTICES, BUSINESS STUDIES, ECONOMICS, ACCOUNTANCY, HISTORY, POLITICAL SCIENCE, GEOGRAPHY, SOCIOLOGY, FASHION STUDIES & PHYSICAL EDUCATION

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
3. As per the newly implemented CCE scheme vide **Circular No. 39/20-09-2009 dated 20.09.2009**, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
5. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
6. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
7. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
8. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
9. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
10. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

(d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.

(e) Schools running on less than 01 acre campus shall restrict number of students as follows:-

11. School will provide physical facilities as per norms of the Board. The facilities reported at the time of last inspection are as given under:-

12. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.

13. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee of **Rs. 25,000/-** and other essential documents in the preceding year before the expiry of the date.

14. The school will open CBSE pattern classes XI w.e.f. 1.4.2012. Accordingly, 1st Batch of class XII of the school will be appearing at the CBSE Examination to be held in 2014.

15. Other conditions are as per **Annexure 'A'** enclosed.

16. **Special conditions to be complied within three months:-**

- The school is required to appoint PGTs in the concerned subjects.
- The school is required to submit the complete land documents of the area 4221+4032 = 8253 sq. mtrs.
- The school is required to purchase more books and reference books for senior secondary classes.
- The school is required to upgrade the Physics Lab by adding more apparatus.

With reference to your application dated.....23.5.2001... and subsequent correspondence with the school/inspection of the school in this regard, I am directed to convey the grant for sanction for Provisional/ Composite Provisional Affiliation for Secondary School Examination of the Board for a period of...3...years, w.e.f. 1.4.2002 to 31.3.2005.

The above sanction is subject to the fulfilment of the following conditions :

1. The school will follow the national syllabus for the middle classes.
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made there in from time to time.
3. The school shall appoint only qualified and eligible staff as per the qualification and experience laid down in the rules for affiliation.
4. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodation i.e. classrooms, Halls etc. available in the school premises and furniture at its disposal for holding its examination free of charge, as and when these are required.
5. The school will spare sufficient teachers for invigilation duties at the examinations of the Board, as may be required.
6. The school will spare its teachers for evaluation of answer-books for the Board's examinations, as and when they are required.
7. The school will provide Laboratories, Library and other facilities as per norms of the Board.
8. The school will abide itself by the conditions of affiliation already prescribed or may be prescribed by the Board from time to time.
9. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
10. Service conditions, scales of pay along with other admissible allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government schools of the State in which the school is located. An undertaking to this effect will immediately be sent to C.B.S.E.
11. The school and its records shall be opened for inspection by an officer/official of the Board or an authorised representative of the Board/State Education Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.



12. The rate of tuition fees and other fees charged should be commensurate with the facilities provided.
13. The admission in the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
14. No unrecognised class shall run with in the premises of the school or outside in the same name of school.
15. The school will not sponsor candidates for Board's examination or any other School/Branch which is not affiliated.
16. The school will create Reserve Fund as per the requirement of the Affiliation Bye-Laws/Rules of the Directorate of Education, Delhi in the joint names, viz chairman CBSE and authorised school authority.
17. The school should not start class XI/XII in the absence of written approval of the Board. The Board shall not be responsible for any consequences in case class XI/XII is started without following the Affiliation bye-Laws and obtaining the prior approval of the Board.

19. Annual fee @ Rs. 1000/- per annum for the year(s) **three (1.4.2002 to 31.3.2005)** be, also remitted at an early date. (In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.)
