With reference to your application dated 29/06/2011 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for Senior School Certificate Examination for a period of three years w.e.f. 01.04.2012 to 31.03.2015 in the following subjects:-

- (a) Languages: ENGLISH (CORE/ELECTIVE), FUNCTIONAL ENGLISH, HINDI (CORE/ELECTIVE)
- (b) Elective Subjects: ECONOMICS, MATHEMATICS, PHYSICS, CHEMISTRY, BIOLOGY, COMPUTER SCIENCE, INFFORMATICS PRACTICES, BUSINESS STUDIES, ECONOMICS, ACCOUNTANCY, HISTORY, POLITICAL SCIENCE, GEOGRAPHY, SOCIOLOGY, FASHION STUDIES & PHYSICAL **EDUCATION**

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

- "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior 1. School Certificate Examination and changes made therein from time to time."
- 2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
- As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the 3. students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level.
