RULES FOR PAYMENT OF MONTHLY COMPOSITE FEE & TRANSPORT MAINTENANCE CHARGES

Session : 2024~25

- It is the sole responsibility of the parents to timely deposit Monthly Composite Fee & Transport Maintenance Charges by the stipulated months & dates.
- School will not send reminders for depositing the Monthly Composite Fee & Transport Maintenance Charges.
- Cash will not be accepted only Digital Mode to be used for Fee Payment
- For any kind of fee related queries or clarification, kindly visit the School Accounts Office in person
- Please do not approach the Principal regarding omission of fine / default penalty.
- School Office Timings: 08:30 AM to 12:30 PM

1. Monthly Composite Fee & Transport Maintenance Charges to be paid through School's Website (www.doonpublicschoolpk.com) in Digital Mode only. NO CASH payment will be accepted by the Accounts Department in the School. The details of Monthly Composite Fee & Transport Maintenance Charges are available on school's website. Transport Maintenance Charges will be as per the location. Transport Maintenance Charges have to be paid for Winter Break or any kind of extended Break by the Govt. If any problem faced in paying Monthly Composite Fee & Transport Maintenance Charges through Digital Mode, contact in person School's Account Office in the first week of fee paying month. In case, Monthly Composite Fee & Transport Maintenance Charges paid through scanner, kindly share the receipt with the School's Accounts Office.
- 2(a). Monthly Composite Fee & Transport Maintenance Charges to be paid on Quarterly basis i.e April, July, October and January or on Yearly basis. If the Monthly Composite Fee is paid for the whole Academic Session in the beginning of the Session i.e April, it will be charged for 11 $\frac{1}{2}$ months instead of 12 months. Monthly Composite Fee & Transport Maintenance Charges have to be paid on or before the last date i.e. the 10th of fee payment month. **Late Fee Fine will be charged @ Rs. 50/- per day after the due date i.e 10th of the fee payment month. 8 % Sibling Concession in the Monthly Composite Fee of the last month of the session i.e. March can be availed for the youngest child (one child only).**
- 2(b). Monthly Composite Fee & Transport Maintenance Charges can be paid on Monthly basis (DIGITAL MODE) only after the approval of a written request made by the parents on the condition that fee / charges shall be paid before 10th of every month, otherwise **late fee fine of Rs. 50/- per day will be charged.** This monthly payment facility cannot be availed in the **FIRST quarter (April to June) and LAST quarter (January to March).** NO WRITTEN REQUESTS will be accepted to this effect.
3. Monthly Composite Fee & Transport Maintenance Charges can also be paid through cheque before 7th of every quarter (April, July, October and January). This facility (payment through cheque) cannot be availed if Monthly Composite Fee & Transport Maintenance Charges is paid on monthly basis. In case of cheque dishonoured, **Rs. 500/- & late fee fine @ Rs. 50/- per day will be charged,** if cheque gets cleared after the last date of fee payment.
4. No Verbal/ Telephonic/ Whatsapp Messages will be entertained for any kind of queries or relaxation in fee / charges payment of monthly composite fee & transport maintenance charges or late fee fine.
5. **Transport Maintenance Charges** will be applicable for only 11 months. There are **No Transport Maintenance Charges for the month of JUNE i.e. Summer Break.**
6. In case any student wishes to discontinue the school transport, **one month notice** in writing should be given, failing which the parents would have to pay the **Transport Maintenance Charges** for the month in question.
7. Child's name will automatically be struck off the rolls in case of non-payment of Monthly Composite Fee or Monthly Transport Maintenance Charges in both cases by the end of the fee payment month.
8. **Re-admission fee @ Rs. 5000/-** will be applicable in case of non-payment of Monthly Composite Fee till the last day of month.
9. If there are any outstanding dues at the close of the year i.e 31st March, Progress Report will be held by the school.
10. The School Management reserves the right to review the Fee Structure and Transport Maintenance Charges.
